All customer credit card information is securely submitted and processed entirely on specialised Stripe systems; Campervanz Rentals staff cannot access, view, process or store sensitive cardholder data (such as credit card numbers, PIN codes or CCV codes). Credit card details are encrypted by the customer's browser before they are sent to Stripe systems and are never exposed in clear-text.

Stripe is globally certified to meet the regulatory security requirements outlined by the Payment Card Industry Data Security Standard (or PCIDSS). PCIDSS certification is required by banks and credit card issuers in order to allow merchants such as Campervanz Rentals to accept payments from customer credit cards. As part of the certification process, Stripe is required by its customers, banks and credit card issuers to implement stringent security controls and undertake regular independent security audits to maintain its certification and security assurance levels.

Where any clause or term above would by any applicable statute be illegal, void, or unenforceable by New Zealand law, then such a clause shall not apply and shall be deemed never to have been included in these terms and conditions. The deemed exclusion of any term pursuant to this paragraph shall not affect or modify the full enforceability and construction of the other clauses of these terms and conditions.

Jurisdiction

This agreement and this website are subject to the laws of New Zealand. If there is a dispute between you and Campervanz Rentals that results in litigation then you must submit to the jurisdiction of the courts of New Zealand.



Drivers' requirements and license

For drivers who owns a Restricted and Learner's licenses, (Campervanz Rentals) don't allow to rent or drive a vehicle. The driver's license must be a Full license. And all drivers must hold a current valid license for the duration of the hire period.

An international or country of origin drivers license is acceptable however if the drivers license is not in English format, then an international drivers license or certified translation is also required. Minimum driver age is 21. No maximum age restriction applies.

Campervanz Rentals has the right to request two recent (within 3 months) forms of address from the hirer before hiring a vehicle to the hirer. Daily hire charges Daily hire charges are calculated on a per twenty-four hour day basis.

Deposit and payments There is 50% deposit required to secure your booking with (Campervanz Rentals). The outstanding 50% is taken on the day the rental period commences.

For afterhours collections, payment is taken 4 working day prior to rental commencement. If the hirer cancels the booking prior to collection then the cancellation policy will apply. Payments should be done by credit cards, bank transfer or cash (in INZD). Campervanz Rentals accepts Visa, MasterCard, however a surcharge fee of 3% on all credit cards transactions applies (including Revolut / Wise cards).

Campervanz Rentals requires a credit card to be used as a bond on all rentals agreements, and this must be the credit card of the main hirer. If you don't have a credit card, we require cash as a bond for the amount of your excess. Your credit card details or cash bond will be retained by Campervanz Rentals up to 15 days following the conclusion of the hire in accordance with these terms and conditions.



Cancellations

Our cancellation fees are as follows:

- Cancelled 90 days before the pickup day on the booking, there are no cancellation fees. Campervanz Rentals will refund the deposit in 4 working days after the hirer emails us the cancellation request.
- Cancelled between 90 and 60 days prior to pick up day, 50% of the rental (including accessories and insurance) is payable to Campervanz Rentals as the cancellation fee.
- Cancelled between 60 and 30 days 25% of the rental (including accessories and insurance) is payable to Campervanz Rentals as the cancellation fee.
- Cancelled 30 days or less prior to the pick up date, no refund whatsoever.

Amendments

If the rental time is reduced but a refund is required, Campervanz Rentals will evaluate the situation and complete the refund within seven days of the confirmation of the modification request when agreed by both parties. If the hirer wishes to extend the rental whilst on hire, they must first obtain authorization from Campervanz Rentals. Any extension is subject to fleet availability and Campervanz Rentals will advise of the additional cost. Failure to obtain authorization (i.e. a late return) will result in the hirer being charged the daily rate plus an additional NZ\$300 for each day.

If the hirer wishes to change the pick up or drop off location after confirmation of the booking, or during the hire period, authorization from Campervanz Rentals must be obtained. Subject to the change being approved, an additional charge of NZ\$800 may apply. If the vehicle is returned early for any reason there is no refund available for the unused portion of the hire. If the hirer's request to change the return location is not granted by Campervanz Rentals and the hirer does not return the vehicle

to the scheduled return location at the required time, the hirer will be liable for all costs associated with the vehicle, including labour, airfare, and even prosecution costs, in addition to the NZ\$800 off-site pickup fee.

1. Mechanical Breakdown & Repairs

Our goal is to keep you on the road, but in the event of mechanical issues, the following protocols apply:

- **Standard Procedure:** In the event of a mechanical failure, the hirer must contact **Roadside Assistance** immediately. If the issue cannot be resolved on-site, a tow truck will be arranged to transport the vehicle to the nearest authorized mechanical workshop.
- **Refund Policy:** If a repair cannot be completed within **72 hours** of the initial report, a pro-rata refund will be issued for the remaining unused days of the booking. Please note that no refunds apply for days prior to the reported failure.
- **Limitation of Liability:** Campervanz Rentals is not liable for any incidental or consequential costs incurred by the hirer. This includes, but is not limited to, accommodation, alternative transportation, meals, or missed activities and third-party bookings resulting from a breakdown.

2. Driver Negligence & Misuse

Insurance coverage is strictly limited to accidental damage and does not cover mechanical failure resulting from improper use. The hirer is liable for the **full cost of repairs** in cases involving:

- **Component Damage:** Damage to the clutch or brakes due to incorrect driving techniques (e.g., burnt-out components).
- **Fuel Errors:** Use of incorrect or contaminated fuel (e.g., putting Diesel in a Petrol engine or vice versa).
- **Ignored Warnings:** Failure to immediately stop the vehicle or contact Campervanz Rentals when a warning light (such as High Temperature or Check Engine) is illuminated.

3. Relocations (via Imoova / Transfercar)

The following specific conditions apply to all relocation bookings made through third-party platforms like Imoova or Transfercar:

- **Ferry Responsibility:** The hirer is solely responsible for booking and securing their own inter-island ferry passage.
- **Failure to Complete:** No refunds will be provided if the relocation is not completed for any reason, including ferry cancellations or failure to book a crossing in a timely manner.
- **Relocation Penalty:** If the vehicle is not delivered to the agreed destination by the specified date/time, a **penalty of \$2,000 NZD** will be charged to cover the logistical costs of vehicle recovery and repositioning.

4. Self Check-In (Auckland & Queenstown)

To provide a streamlined experience, our Auckland and Queenstown depots operate on a digital-first basis:

- **Process:** Vehicle collections at these locations are strictly "**Self Check-In.**"
- **Guidance:** Detailed instructional videos demonstrating the basic operations of the campervan will be provided to the hirer via email or mobile.
- **No Staff Briefing:** Please be aware that **no in-person demonstrations** or staff briefings will be conducted at these locations during the pick-up process.



Fuel

All vehicles are supplied with a full tank of fuel and accordingly, all vehicles must be returned with a full tank of fuel. If the vehicle is returned without a full tank of fuel, the hirer is liable for the cost of the fuel, plus a fee of NZ\$150. * This doesn't apply to relocation contracts where the fuel refund policy is explicit in the contract (Imoova / Transfercar).

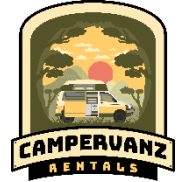
Extra fees

- If the vehicle is not returned in a tidy condition, a fee of NZ\$250.00 will apply
- If smoking is undertaken inside the vehicle, a fee of NZ\$250.00 will apply.
- No Pets. a \$250.00 cleaning fee will apply.



Traffic infringements and fines

All traffic infringements and fines are the responsibility of the hirer. Campervanz Rentals will contact the hirer to inform of the fine (speed ticket, parking ticket, etc), if there is no response from the hirer, Campervanz Rentals will charge the hirer's credit card the cost of the fine, plus a processing fee of NZ\$50 in the event of an infringement or fine being received from a relevant authority. In the circumstances of credit card failure, or no credit card is supplied, Campervanz Rentals reserves the right to pass on the hirer's details to the relevant authority. If additional court overdue payment and fines are incurred as a result, the hirer must pay the citation, additional fines, court overdue payment, and other related costs. If, as at the completion date of your rental agreement, any costs associated with your rental have not been paid, or subsequent to this completion date you become liable for additional costs in relation to your rental agreement, we reserve the right to refer your account to a debt collection agency. In these circumstances, and solely at our discretion, you may become liable for all costs incurred by us in relation to the collection of this debt (including but not limited to internal administration fees, legal fees, collection agency fees, and bank fees). The Hirer agrees that Campervanz Rentals will have the right to refuse any rental and/ or terminate the hire and take immediate possession of the Vehicle, without notification to the Hirer, if: (i) the Hirer fails to comply with any of the material terms and conditions of this Agreement, (ii) the Hirer has obtained the Vehicle through fraud or misrepresentation; (iii) if the Vehicle is damaged; or (iv) in the reasonable opinion of Campervanz Rentals and/or the NZ Police the Authorised Driver(s) do not have sufficient skill or experience to operate the Vehicle in a safe manner or the safety of the passengers, members of the public or the Vehicle is at risk. In such event the Hirer will: (a) not be entitled to a refund of part of the rental charges; and (b) be responsible for the payment of any towing costs to return the Vehicle to the Return Location plus a fee to cover the reasonable costs of Campervanz Rentals arranging the return of the Vehicle. This includes the extension of the hire if the vehicle cannot be recovered to a Campervanz Rentals depot by the completion of the hire.



Insurance

Campervanz Rentals does not deduct the insurance excess (bond) from your credit card, but merely hold the authority to deduct it as per these terms and conditions. If you don't have a credit card, we require a bank transfer a bond for the amount of your excess. If there is no loss/damage or any reported incidents, speeding fines or parking tickets we will release the bond in 15 days after your hire ends. The liability for damage to the vehicle is applicable to the hirer regardless of who is at fault. If the hirer is not at fault, and the third party admits liability, then a refund will be processed upon receipt of payment from the third party. Insurance needs to be renewed in the event of an insurance claim. Insurance does not cover the transportation of a replacement vehicle following an accident. All damage must be reported within 24 hours for insurance to apply.



Insurance Exclusions

This means there is no cover and the customer is liable for the full cost of repair/replacement to the vehicle, third party property, and accessories hired.

- Damage is caused due to unlawful driving
- The driver receives a charge of reckless or dangerous driving by the New Zealand Police
- Damage is caused when these terms and conditions are breached
- Damage is caused due to negligence or willful conduct
- Damage is caused due to the use of incorrect or contaminated fuel
- Damage is caused due to using the vehicle in contravention of any legislation or regulation
- Insurance options do not cover loss or damage to accessories hired
- Vehicle rollover
- Underbody damage
- Overbody damage
- Driving under the influence of drugs or alcohol
- The hirer takes the vehicle onto a beach or off road
- The hirer takes the vehicle onto road not paved with asphalt, cement, concrete (gravel roads)
- Damage caused by road hazards – such as punctures from nails or sidewall damage from hitting a curb
- Insurance does not cover the cost of repairing damaged car keys/remote and the cost of matching new keys after losing the key/remote.

Excess reduction options

There are three levels of insurance excess options available to the hirer. Basic Insurance / Excess Reduction A / Excess reduction B.

Our rates include Basic Insurance with an excess of NZ\$4000. The hirer can choose between 2 options to reduce the excess:

Option A: Pay an additional NZ\$39.00 a day to reduce the insurance excess to NZ\$1000

Option B: Pay an additional NZ\$59.00 per day and reduce the insurance excess/bond to NZ\$0 (nil).

Insurance does not cover, damage caused from snow chains, underbody or over body damage (including if the vehicle has a rollover), or towage costs associated with any damage.

Mechanical Faults

The hirer shall take all reasonable care to ensure that the vehicle is properly maintained during the hire period. This shall include daily checks of the oil, water and battery. The vehicle is covered by 24 hour, 7 days, road-side assistance with AA. If the vehicle has any mechanical failures during the hire these issues must be reported to Campervanz Rentals soon as possible in order to give Campervanz Rentals an opportunity to rectify the issues during the rental. The hirer is not entitled to any refund unless Campervanz Rentals has been advised of the issue, and has been given the opportunity to rectify the situation. Campervanz Rentals is not liable for any delay in repair caused by a breakdown occurring on a weekend, public holiday or remote location. Depending on what caused the mechanical issue (drivers fault / normal wear and tear), a substitute or alternative vehicle might be provided. A substitute vehicle will always depend on availability. Campervanz Rentals is not responsible for any additional costs or refunds such as accommodation, transportation, meals, and re-rental costs. Campervanz Rentals reserves the right to substitute an alternative vehicle without prior notification, and at no extra cost to the hirer or cancel the booking and make a partial or full refund depending on the nature of the mechanical fail. In the event of an accident involving the hirer or any additional driver, Campervanz Rentals under no

obligation to provide a replacement vehicle. The unused portion of the hire is not subject to refund.

Data Collection

Campervanz Rentals reserves the right to collect information on the hirer. Specific vehicles in the Campervanz Rentals fleet collect data on a per journey travelled basis. Campervanz Rentals reserves the right to retain such information and has the right to use such information at its own discretion.

Campervanz Rentals reserves the right to amend these terms and conditions, vehicle specifications and tariffs at any time without prior notice. Campervanz Rentals reserves the right to refuse any rental at its own discretion.

All tariffs are in New Zealand Dollars (NZD) and are inclusive of New Zealand Goods and Services Tax (GST).
